Students are exposed to latest industry job demands, work culture and also get tutored by experts and academicians. This earn and learn model also gives flexibility of entry and exit to the students.

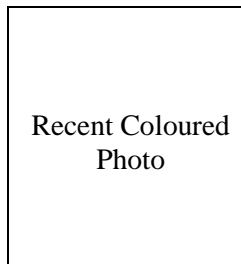
